DUES FINANCING PROGRAM TERMS

COLLATERAL: Because we are not a commercial bank, we need to ask you for something in order to be able to provide you with financing for your 2015 Membership Dues : On-Time Payment of Financing Charges. If you can handle this then we shall approve your Dues Financing Application! **PAYMENTS SCHEDULE:** The payments schedule has been outlined above. We will not be adjusting this schedule in any way, so please don't ask us to. **PAYMENT TYPES:** We will accept the following payment types: (1) Post-Dated Cheques, as per the schedule outlined above (2) Credit Card Payments: Visa, Mastercard or American Express. **DECLINED PAYMENTS:** NSF Cheques or Declined Credit Cards will carry an additional \$40 late processing charge. If your payment is not caught-up within 7 days we will be charging you an additional \$25 every 7 days until you have caught up to the Finance Schedule that we have outlined and that you have agreed to, as per this application. If you are behind in your payments once the 2015 season has opened, your playing privileges will be suspended until such time that you have caught-up to the payment schedule. These terms are rigid and will not be adjusted, remember that we are not a bank and as such we get to make up our own rules. Should you adhere to the schedule outlined above, you have nothing to worry about with respect to late fees and penalties.
